**ESTABLISHMENT OF THE ACCURACY OF BANK ACCOUNT NUMBERS RELATING
 TO THE PAYMENT OF FERTILIZER SUBSIDY CASH GRANT TO PADDY FARMERS
 DURING MAHA SEASON 2016/17 AND OTHER FIELD CROPS
CULTIVATING FARMERS IN 2016**

Instructions have been issued by the circular No: NFS/FCG (3) 2016/17 Maha dated 15.08.2016 that the relevant bank should certify with official frank the information contained in FCG 2 – i.e. farmers Account Numbers and the name of the Branch Numbers are correct.

However, it is observed that in areas where a large number of farmers are available fulfilling that requirement has been difficult.

Accordingly, following the discussion I had with the Asst. General Manager of the People's Bank today, it has been agreed to make available a FCG 02 DVD Disk and establish the accuracy by the Head Office of the Bank.

Therefore with regard to areas where there are a large number of such farmers you are kindly informed to take action to make available duly filled FCG 02 to Asst. General Manager through a responsible officer and get their accuracy certified accordingly.

It is convenient that the FCG 02 data which have been rejected by the head office of People's Bank to be corrected and to get recommended by the Divisional Branches.

Accordingly, you are kindly informed to instruct all Dy/Asst. District Commissioners and DO's to follow the above instructions in this regard.
