Implementation of Budget Proposals

Providing cash subsidy to paddy farmers to purchase fertilizer during (2016/17 Maha) and granting cash subsidy to purchase fertilizer for other filed crop (2016)

This is further to two circulars dated 12.08.2016 and two guidelines dated 19.08.2016 addressed to you on the above subject.

According the those Circulars and Guidelines are revised as follows;

1. If one farmer owned more than one paddy land within the same 'Grama Niladhari' Division / KUPANISA Division all these land blocks shall be included in the same application numbering each blocks and cash subsidy should be calculated on the total.
2. By paying attention to above factors, DO's serial Number (code number) in FCG 2(P) and FCG 2(H) forms should be computerized in the following manner and ensure to include that number in both the application and the receipt correctly.

District No. / DO's Division No. / GN No. / Ownership / Bank No. / Serial No

2.1 In giving the above code Number, the following Numbers shall be made available on the "ownership" of the land.

- Name of the owner – 01
- If a tenant farmer – 02
- In case of leases farmer – 03
