### **Correction of information of paddy farmers who did not receive fertilizer cash subsidy during 2016/17 Maha due to rejection of accounting**

The lists of paddy farmers who did not receive fertilizer cash subsidy during 2016/17 Maha due to rejection of accounting have been sent to us by the respective banks. (The rejected lists have already been emailed to you) Given below are the reasons for non crediting of money to those bank accounts.

- 1) Having provided Investment Account numbers
- 2) Existence of closed accounts
- 3) Having incorrect account numbers (Refer the letter No.7/1/3/2 Budget Proposals (General) dated 17.10.2016 with regard to the inclusion of bank branch numbers and account numbers in FCG 02)
- 4) Indication of incorrect bank branch numbers

As resubmission of rejected lists early with necessary corrections is essential, you are kindly informed to take the following measures through Agrarian Development Officers.


- 1 Instruct those farmers to open a 'Govi Diriya' new account immediately in the relevant bank and prepare revised FCG (2P) within one week by entering Bank Branch, Branch Code and the new Account Number. Strictly Instruct them to open the Bank Account at any branch of the same bank to which the information were submitted originally and then establish the accuracy ( The relevant banks have already agreed to open 'Govi Diriya' Accounts without basic deposit and not to deduct farmers' loans from those accounts)
- 2 At the correction of lists rejected by respective banks (BOC, People's Bank, NSB and Regional Development Banks) inclusions should be limited only to beneficiaries entered in the rejected lists and it is to be stressed that non adherence to this instruction may result in the total list being rejected.

- 3 At the revision of rejected lists any information other than Account Number, Bank Branch and Branch Number should not be changed contrary to the original lists (DY/Asst.Comm. Serial No./DO'S Serial No./GN Division/Farmer's Name/Farmer's NIC No./Farmers Address/Payable Subsidy (Rs.)/Land Extent (ha)/Farmer's Telephone No.)

Summary lists of FCG 3,4,5,6 shall be prepared in line with FCG (2P) report revised above and uploaded the same in our website. You are kindly requested to hand over personally their certified DVD copies and Hard copies with district level signatures (ADS, Dy/Asst. Commissioner of Agriculture Development and Asst. Director (Fertilizer) in charge of the respective district before 22.01.2017.

Data to be submitted contrary to the above are subjected to comparison automatically within the computer network system and they may be rejected and emphasized the need of having published the lists of all registered farmers qualified and entitled to receive cash subsidy for 2016/17Maha . Your co-operation in this regard is highly appreciated.
